Please Do Not leave your Garage Door Opener in your vehicle when parked outside (allows for easy access into your home). Please park your locked vehicles in your locked garage, whenever possible. Purchase Wheel Locks for premium Wheels/Tires & 3rd Row Seats. Have a Neighbor Pick Up Your Newspapers, Packages, front door flyer's/ads when you are Out-of-Town, leave a number and date you will return. Buy & Install Timers for Porch & inside lights (do not leave porch or driveway lights on all day). Newer Alarm System technology allows you 3641 Rodale Way to Arm/Disarm, View Cameras, Control Lights, and much more. Install Motion Sensored Lights for driveways/garages or use timers. Please TURN ON Outdoor Lights.

**PLEASE ACTIVATE YOUR ALARM SYSTEM and make sure you have a current Alarm Permit with the City of Dallas on file with your Alarm Company-Dallas Police Will Only Respond to Alarm Calls Granbury Drive With Active Permits On File. There have been several incidences, including in our neighborhood, where an Alarm went off and the Police refused to come out.

Get to know your Neighbors! Please be Observant and look out for your neighbors. If you hear alarms sounding or strange noises, please don't ignore them, look out the Sam Rayburn Trail window, Call 911.

TIMBERGLEN PARK UPDATE

As many of you probably have noticed, the work on the improvements to Timberglen Park is almost complete. Here is the latest information that we received from the Dallas Parks Department on January 22:

"We are currently trying to finish up the project, although essentially it is largely complete and parts of it are already "in service". The trail and other amenities are being used by the public now, but the soccer fields and softball diamond remain "off limits" to allow the grass (sod) time to get established. The fields will remain closed until at least early summer, or until the sod is properly established. Our staff will make that determination. We will get the fields open as soon as it is possible to do so.

It is important for you to stress in your newsletter to the HOA that the fields are currently CLOSED to allow time for the grass sod to get established. Unfortunately, I can't give you an exact time that they will open, but again, we are hoping late spring or early summer. We don't want to have spent all that money for special Bermuda sod only to have it torn up because it's not properly established. The rain we are currently getting will help considerably.

We did the Handicapped accessibility inspection early last week, and there were some issues coming out of that inspection that need to be addressed. The Contractor will need to make some modifications to the handicapped spaces in the parking lot. We will be doing this within the next couple of weeks. We were supposed to meet today to make some decision but the rain has pushed us back to next week. I'll keep you in the loop about that as we get things resolved.

Regarding the fence and/or guardrail, we are finishing out the main project now. As soon as that's done, we will sit down and look at our remaining budget and see how much we have left. We hope to pay for these items with any remaining funding which may be available. We will likely get our Facilities Services Group to help us with the fence and guardrail. *

Again, I realize that's not an exact time frame, but we will do everything possible to make sure it is addressed as quickly as possible. I will coordinate with you as I have more information."

* The fence and guardrail projects include completing the black fence to go along the west side at the White River Drive easement and the completion of the fence, along with a gate, at the north end of Summerfield Drive.

We have also met with City Officials about the ugly barriers at Summerfield Drive and Whit River Drive. Here is the report from the City Engineer that we met with:

"None of this work is funded and the amounts are estimates.

Dead-end at the north side of Summerfield

When the Parks Department erects/extends their fence along the dead-end street, dead end signs can be posted ... and a curb with storm water drainage can be installed. Cost of curb and signs...\$1.000 - \$2.000

Dead-end at the east end of White River Drive

Installation of a sidewalk and curb curving along the dead-end

Cost is as follows: \$1,000 for saw cutting and demo \$25/If for curb and gutter to be added... \$45/lf for 5' sidewalk against curb... Total: \$20,000"

We will keep you updated, through email messages, as we receive additional information from the City about these two projects as well as the park.

Thankfully no one was hurt, and our condolences go out to the residents whose homes were burgled. We will have a representative of the DPD at our next Board meeting February 5 at 6:00 p.m. at the library. If you miss it, I will send out a recap the next day.

Until then, Police are asking for your help in following the Crime Watch Tips BELOW:

***CRIME WATCH REMINDERS:

Please check your front door/porch daily for packages. Please keep your purses/wallets/ cell phones in sight and in your possession at ALL Times when shopping, running errands and dining out. Try to avoid going to ATMs after dark. Criminals will take advantage and "bank on" you being distracted, even when entering your driveway - that text, call or e-mail can wait until you are safe in your home with the garage door closed and doors

PLEASE Lock Your Doors, Windows, Fence Gates & Vehicles. Turn On Your Home Security ALARM System - when home/when not at home because they may come in when you ignore the doorbell/ knocking or when you are asleep. Have your Alarm Company install "Glass Breakage" sensors. Please Keep Your Garage Closed at all times (strangers routinely drive & walk

The white rock terrace is the first thing that catches your eye, followed by a plethora of carefully placed flowers, including hostas, vincas, and varieties of elephant ears. Everything neatly trimmed. Thanks Bob and Pat for your pride in our neighborhood.

This is from an email from Jandis Price, president of Villas of Midway:

ALL-WAY STOP SIGNS INSTALLED AT VAIL AND TIMBERGLEN ROAD

I have been working with the Dallas Police Dept. since May to address the traffic safety issues on Timberglen Road between Marsh and Lina Streets. Those of you who attended our Annual HOA Meeting, earlier this year will recall I showed photos of damaged perimeter walls on Timberglen Road caused by speeders and drunk drivers. This is IMPORTANT to Villas of Midway HOA because we own the perimeter brick wall from the alley by the school, to just passed the Sam Rayburn Trail Stop Sign to the end of the drainage ditch. Each accident costs anywhere from \$4,500-\$7,500 to repair. This is also IMPORTANT to Midway Meadows VHOA, because the homeowner who lives closest to the damaged wall is responsible for the repairs, because they have a Voluntary HOA. There have been 5-6 Wall Accidents, so far in 2014 - This is Unacceptable!

We tried deploying Police Patrols to cite speeders, but realized we needed a more permanent solution, so I contacted the City of Dallas Streets Dept. Engineer to find a more permanent solution.

We asked Dallas Streets Engineers to conduct a Traffic (volume) and a Speed Study on Timberglen Road between Marsh Lane and Lina Streets. I am including a few highlights - All shown speeds are the "85th percentile speed" which is considered the speed at which most motorists feel comfortable driving.

- Westbound Traffic between Sam Rayburn and Lina travel at 34 MPH
- Eastbound Traffic between Sam Rayburn and Lina travel at 42 MPH
- Westbound Traffic between Vail and Sam Rayburn travel at 36 MPH
- · Eastbound Traffic between Vail and Sam Rayburn travel at 27 MPH
- Westbound Traffic between Vail and Marsh travel at 53 MPH
- · Eastbound Traffic between Vail and Marsh travel at 28 MPH

As a result of the Study, the City confirmed that All-Way Stop Signs were warranted on Timberglen at Vail. The City Streets Engineer also shared plans to install a Traffic Signal Light for Timberglen at Marsh, which is currently under design and should be constructed in about a year from now.



Reflective flags have been temporarily installed on the STOP Signs to alert drivers to the change. Please let your neighbors and friends know about the new Signs.
